### **Pedigree Analysis: Carrier Probabilities**

- If the child inherits the first parent's other allele, the child will not be a carrier Since there are a total of two equally likely outcomes, and in one of those two cases the child is a carrier, the probability that the child is a carrier is  $\frac{1}{2}$  or 0.5
